Based on a mutual understanding to support each other's efforts to improve the quality of human resources through developing the educational institutions, research, and community service, on **Friday**, date **Sixteenth**, month **March**, year **Two Thousand Eighteen** (2018) at Pattani Thailand, this Memorandum of Understanding (hereinafter referred to as "MoU") is made and entered into by and between:

1. **K.H. Abd. Hamid Wahid, M.Ag.** : Rector of Nurul Jadid University (UNUJA) whose address is PO BOX 1 Karanganyar Paiton Probolinggo, a higher educational institution under the Foundation of Nurul Jadid Islamic Boarding School formally inaugurated under Letter of Decision of the Minister of Research, Technology, and Higher Education, Republic of Indonesia (Kemenristek Dikti RI) Number 589/KPT/2017 hereinafter referred to as **THE FIRST PARTY**.
2. **Sayuti Hayeetahay** : President of Abroad Alumni Association of Southern Border Provinces, whose address is 300 / 122 M. Omthong Jln. Nongkchik M.4 T.Rusa milea A. Muang CH. Pattani 94000 hereinafter referred to as **THE SECOND PARTY**.

DECLARATION

This MoU is made and entered into by BOTH PARTIES in terms of a cooperative understanding with the following aims and conditions:

Article 1
Terms of Condition

This MOU is effective upon the day and date last signed and executed by the duly authorized representatives of the parties to this MOU and the governing bodies of the parties' respective counties or municipalities and shall remain in full force and effect for not longer than 5 (five) years. This MOU may be terminated, without cause, by either party upon 5 (five) years written notice, which notice shall be delivered by hand or by certified mail to the address listed above.

Article 2
Purpose

The purposes of this MoU are:

1. To improve THE FIRST PARTY's and THE SECOND PARTY's institutional capacities in developing professional education programs in terms of teaching and learning activities, research, and community service.
2. To develop a broader access to scientific and technological information exchange and other information, whether regarded to this MoU or in the framework of broader development on the basis of mutual benefit.
3. To establish an international cooperation in the development of study programs, student exchange, teacher exchange, staff exchanges, and scientific activities, including conference, seminar, etc.

Article 3
Scope

1. This MoU is an ultimate agreement containing the terms and conditions of cooperation between the FIRST PARTY and the SECOND PARTY in terms of teaching-learning, research, and community services (*tridharma*).
2. THE SECOND PARTY, under their certain limits of ability, shall seek to provide an assistance in development of educational programs, either for relevant fields, research programs, community service, or joint ventures.
3. The SECOND PARTY is willing to accept students from the FIRST PARTY to continue their level of education under the SECOND PARTY's agency.

Article 4
Applicable Law

The FIRST PARTY and the SECOND PARTY will make a subsequent agreement on following procedures of this MoU through officers or representatives appointed by their respective agencies. The accommodation, facilities, and funding for the sake of this MoU shall be borne by their respective institutions under the agreement of BOTH PARTIES.

Article 5
Duration and Legality

1. This MoU is based on the good desire of BOTH PARTIES to help each other in the effort to execute their institutional role as well as possible.
2. Any constraints or inadvertence that may occur during the process of MoU period will be settled by deliberation.
3. This MoU shall come into force since the BOTH PARTIES' legal signature for a term of **5 (five) years** which may be extended upon their agreement.
4. The MoU is made in 2 (two) copies with inserted stamp to provide an equal legal force.
5. This MoU shall enter into force on the date of signature by BOTH PARTIES.
6. The technical procedures of any program under the MoU shall be prepared and made in a separated sheet.
7. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by all parties to this MOU.
