



MEMORANDUM OF AGREEMENT (MoA)

between

Regional Polytechnic Institute Techo Sen Takeo (RPITST)

and

Sekolah Tinggi Teknologi Nurul Jadid

about

The Dual Degree Program

KNOWN ALL MEN BY THESE PRESENTS:

This agreement entered into and executed this Tuesday of November 21, 2016 at Malang by and between:

Regional Polytechnic Institute Techo Sen Takeo, principal office at Phumi III, Rokakhnong Commune Daunkeo Town, Takeo Province, Cambodia, hereinafter referred to as **Regional Polytechnic Institute Techo Sen Takeo** and represented in this instrument by its Deputy Director, Mr. Thou Sopheap.

and

Sekolah Tinggi Teknologi Nurul Jadid, Indonesia, which is located at Paiton Probolinggo East Java, here in after reffered to as **Sekolah Tinggi Teknologi Nurul Jadid**, and represented in instrument by its Chairman, Najiburrahman, MA.

WITNESSETH

RECOGNIZING that academic co-operation among institutions, either through similar or complementary activities would bring about mutual understanding and unity in purpose.

REALIZING that sharing expertise, resources and facilities would reinforce mutually beneficial problems.

WHEREAS, RPITST and Sekolah Tinggi Teknologi Nurul Jadid have the mandate to support the human resources development program especially in the area of Information Technology.

NOW, THEREFORE, RPITST and Sekolah Tinggi Teknologi Nurul Jadid, in consequence of the above premises hereto agree to jointly develop and implement **The Dual Degree Program**, as they have agreed on the following:

**Article 1
General Stipulation**

In this Memorandum of Agreement, the partnership between RPITST and Sekolah Tinggi Teknologi Nurul Jadid defines as cooperation in term of education development.

**Article 2
Objectives**

This Memorandum of Agreement is expected to improve institutional relationship between the two parties to be able to mutually contribute in the human resource development and the quality improvement of institution to fullfill the international education standards.

**Article 3
Scope**

1. Lecturer exchange to gain new academic atmosphere, and to share experiences;
2. and knowledge in relation with the improvement of teaching and learning process;
3. Workshop on curriculum development and its implementation to fulfill the international standard;
4. Education development and trainings for instructors or lecturers will be based on training need analysis;
5. Student exchange;
6. Co-conducting Bachelor Dual Degree Program with model 3+1 in IT (three years in original institution and one year at partner's institution based on curriculum mapping).

**Article 4
Implementation**

1. The implementation of this agreement would be specifically and further defined by both parties.
2. The implementation of this agreement can be discussed by two parties in Indonesia or in Cambodia.

**Article 5
Funding**

1. Sekolah Tinggi Teknologi Nurul Jadid will be responsible for the preparation of program in Indonesia.
2. RPITST will be responsible for the funding of air ticket, other travel expenses and the allowance of/for RPITST participants.

3. Sekolah Tinggi Teknologi Nurul Jadid will provide facilities which are relevant with the request of management of *RPITST* based on its ability.
4. All equipment for e-Learning program will provide by hosting institution.

**Article 6
Terms**

1. This Memorandum of Agreement shall be valid for 3 (three) years, and taking effect from the date the agreement signed by both parties. The agreement might be automatically extended, changed, or canceled at any time, agreed and approved by involve both parties upon in writing.
2. This Memorandum of Agreement shall be terminated if there any clause or term of it that is in contradiction with the Cambodian and Indonesia regulation.

**Article 7
Problem Solving**

Should there be any conflict regarding this agreement occurred between the two parties, discussion and deliberation would be chose to solve the conflict.

**Article 8
Others**

1. The commitment made between the two parties in this agreement is subject to the capability of each party while obeying the agreed rules and regulations.
2. Other related matters that has not been arranged, would be further discussed by both parties.

**Article 9
Closing**
